Signing of a share buyback agreement for a maximum amount of €150 million

Paris, January 8, 2019 - <u>Cappemini</u> announces the signing today of a share repurchase agreement with an investment service provider for a maximum amount of 150 million euros.

The price per share will not exceed the arithmetic average of Capgemini SE daily volume weighted average share prices over a period starting on January 8, 2019 and ending no later than February 13, 2019, before applying a contractual discount.

This agreement is part of Cappemini's multi-year share buyback program. The terms of this operation are compliant with the authorization granted by the Shareholders' Meeting of May 23, 2018.
